Eighth Carlsberg Academy conference, Copenhagen 4<sup>th</sup> to 6<sup>th</sup> May 2011: **Law and marriage in the Middle Ages and Early Modern times**. Keynote Speakers: Prof. Charles Donahue, Jr. (Harvard Law School) and Prof. Philip L. Reynolds (Emory University, Candler School of Theology).

Law, Violence and Social Bonds, c. 900-1250. Call for papers for a three-day conference entitled **'Law, Violence and Social Bonds, c. 900-1250,**' hosted by the St Andrews Institute of Mediaeval Studies, 17-19 June 2011.

Considering attitudes towards lawful and unlawful violence in relation to social bonds - be they familial, seignorial or spiritual - and bringing together a number of distinct conceptual approaches, such as anthropology, sociology and prosopography, this

conference will offer new avenues of research and discussion.

The two keynote speakers for the conference will be Dominique Barthélemy (Université Paris Sorbonne – IV) and William Ian Miller (University of Michigan Law School); six invited speakers will offer shorter papers discussing the conference themes within different contextual milieux.

We invite proposals from postgraduate and postdoctoral scholars from any relevant Mediaeval discipline for 20-minute papers, encouraging in particular considerations of the interactions and relationships amongst law, violence and social bonds.

Please send abstracts for papers of 20 minutes, of no more than 250 words, to <a href="livsb@st-andrews.ac.uk">lvsb@st-andrews.ac.uk</a>. The deadline for submission is Friday 11 March 2011.

International Workshop at the Abbey of Fontevraud, 17-18 October 2011: **Jews in the ecclesiastical, Roman-barbarian and Byzantine law (sixth to eleventh centuries)**: changes, ruptures, adaptations. This workshop will provide an opportunity for renewed reflection on the legal conditions of Jews in Latin Europe and Byzantium in the early middle ages.

The workshop will address such topics as the status of the synagogues, liturgical requirements, prohibitions concerning sexual relations and commensality, the problem of conversions to Judaism, proselytizing, apostasy, crypto-Judaism, exclusion from public functions, or laws concerning property (landed estates, slaves) and usury. The vast majority of these measures have their roots in Roman law. Analysis of their reception in both ecclesiastical and secular laws of Latin Europe and Byzantium should permit us to perceive continuities, adaptations, changes or disruptions in legal theory and practice.

These proposals are indicative and by no means exhaustive; other lines of inquiry are welcome. Communications will be in French or English and will last 30 minutes. The organizers will pay transportation costs and accommodation for those presenting papers.



## MOSAICO PROJECT

In 2008, the Italian Government promoted a research project presented by a Consortium of Universities [University of Bologna- CIRSFID (coordinator), Roma Tre University of Rome, Federico II University of Naples], named "Piecing together a Mosaic: Describing, Digitizing and Using Medieval Legal Manuscripts". The goal of the "Mosaic project" is to portal Web 2.0 (online create http://mosaico.cirsfid.unibo.it), containing homogenous descriptions of medieval codices connected with a collection of digital manuscripts which can be viewed in high resolution.



The portal provides access to a significant database, collecting much information about legal manuscripts

dispersed in thousands of academic publications of specialized literature. The history of academic use of these manuscripts from the 19<sup>th</sup> century onward will be reflected in the form of the records collected. Several manuscripts will be newly described and commented by world-wide known scholars, such as Profs. Bellomo, Bertram, Condorelli, Conte, Dolezalek, Loschiavo, Martino, Vano, Winroth, and others who will join the project in the near future.

Hugh's efforts in disseminating reform in France in the 1070s, 1080s, and 1090s were shaped by his council activity. The manner in which he conducted this business sheds light on every aspect of his work, revealing not only his personal interpretation and application of the law, but also his vigour in suppressing clerical marriage, the selling of church offices, lay investiture, and the gravity with which he conducted his duties as legate. New light is cast on Hugh's personality and achievements by looking at the nature and influence of his legatine and legal activity in France. Dr. Rennie is Lecturer in Medieval History at the University of Queensland, Brisbane, Australia.

A strict definition of kinship – a canonical one – was in introduced in to the Nordic medieval legislation, replacing an older, looser one. According to a canonical definition of kinship – constructed after the

Church's incest prohibitions, you were obligated towards all your blood-relatives. This doctrine applies where: 1) The kin group acted as a legal person towards a third party in cases about paying of wergeld, and where the kinsmen collectively took an oath. 2) Rights and obligations between the kindred regulated land transactions either by inheritance, donations or sale. Here the obligations were at their widest. The moral requirement for love and cohesiveness was strengthened by more substantial rules to ensure, that land was not transferred at the expense of kinsmen.

# **DISSERTATION**

Émilie Rosenblieh defended her dissertation *Juridiction conciliaire et juridiction pontificale au temps du concile de Bâle (1431-1449). Recours, procédures et suppliques* on December 6, 2010, at Université Paris 1 Panthéon-Sorbonne.

### WEB SITES

There are two new sets of images in the Yale Law School Rare Book Collection's Flickr galleries: *Tractatus iuris* (1549) and *Tractatus universi iuris* (1584-86). The images include tables of contents and indexes of authors and titles for these two massive compilations of Roman and canon law scholarship. The images were cropped and edited for legibility, not for aesthetics.

The 18-volume *Tractatus ex variis iuris interpretibus* (1549) was published by a consortium of Lyon printers. Its tall folios contains 458 separate works by over 200 different authors on virtually any topic of interest to lawyers and jurists of the time, and served as a sort of encyclopedia of the *ius commune*. Topics include arbitration, contracts, heresy, debt, adultery, taxation, judicial torture, banking, estates, criminal procedure, and the law of war, to name just a very few. Most of the leading authors of medieval and Renaissance jurisprudence are represented, including Baldus, Bartolus, Durandus, Odofredus, Jean Montaigne, Jacobus de Arena, Johann Oldendorp, and Guy de la Pape.

A much-expanded edition, the 22-volume *Tractatus universi iuris*, was issued in 1584-86 by the Venetian publisher and bookseller Francesco Zilletti. It contains 754 titles by 362 authors, including several jurists who rose to prominence after the publication of the 1549 edition (i.e. Joost de Damhoudere, Benvenuto Stracca).

### **AUDITA ODOFREDI**

After finishing her dissertation on *Bigamy in Late Medieval France* at Yale University, Sara McDougall is teaching at John Jay College of Criminal Justice as an assistant professor of history. The college is a part of the City University of New York (CUNY) system.

After finishing her dissertation on From Gratian's Concordia discordantium canonum to Gratian's Decretum: The Evolution from Teaching Text to Comprehensive Code of Canon Law at the Catholic University of America, Melodie Harris Eichbauer is teaching at the Florida Gulf Coast University as assistant professor of history. Among her courses during the fall semester of 2010 was the history of Roman law.

After finishing his dissertation on *The Papacy and the Use and Understanding of the Pallium from the Carolingians to the Early Twelfth Century* at Columbia University, Steven Shoenig, S.J., is teaching at St. Louis University as assistant professor.

Gregory Roberts, a graduate student at Yale University, has won a Fulbright fellowship to Italy for research on his dissertation entitled *Law enforcement in medieval Italian communes*, 1260-1330. He is doing most of his research in the city archives of Bologna with their rich fond of judicial records.


The President of the Stephan Kuttner Institute of Medieval Canon Law, Peter Landau made a trip to Japan and Taiwan in November to give a number of lectures on topics of interest to medieval canon law. He was joined in Tokyo, Niigata, and Sapporo by the secretary Anders Winroth.

### CODEX IURIS CANONICI IN CHINESE

The 1917 *Code of Canon law* exists, of course, in translations into many languages (just like the 1983 *Code*). Our colleague Peng Xiaoyu (PhD, Catholic University of America, 1998), professor of history at Peking University, has shared a photo of the 1943 translation into Chinese. This was the result of col-

laboration between the German-born Cyrill Jarre, OFM (later archbishop of Jinan, China) and the Chinese judge Li Ki Jen. Professor Peng judges the translation very felicitous. Its language harks back beautifully to the ancient legal tradition of China. The book is also very handsomely printed. An impressive achievement. (The Code of 1983 has also been translated into Chinese).
